

**AMENDMENT No. 1 TO
INTERLOCAL CONTRACT FOR LICENSING SCPDC SOFTWARE**

THIS AMENDMENT No. 1 (“Amendment”) is entered into by and between the Mayor and Council of Rockville (“**Licensee**”), a municipal corporation and body corporate and politic organized under the laws of the State of Maryland; and South Central Planning and Development Commission, (“**SCPDC**” or “**Licensor**”), a regional planning commission and political subdivision of the State of Louisiana, domiciled in Terrebonne Parish.

WITNESSETH:

WHEREAS, the parties previously entered into the Interlocal Contract for Licensing Agreement SCPDC Software, including the City of Rockville Standard Contract Addendum, on or about February 17, 2021 (the “**Agreement**”), attached hereto and incorporated by reference. The parties desire to amend said Agreement as set forth below:

1. **The Permits Module / Monthly \$3,167, Planning & Zoning / Monthly \$1,583.50, Fire Safety Module / Monthly \$300, GIS / Monthly \$230, Hotels and Apartments Module / Monthly \$475, DPW Module / Monthly \$300, Miscellaneous Module / Monthly Included in SaaS, Police Module / Monthly \$475, Solutions Center / Monthly \$475, Total Monthly \$7,005.50.**
2. **Onsite Training** shall be added to this Agreement under a custom quote of \$2,700.00 per trip. Remote sessions will be used when feasible.
3. **Modifications.** Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.
4. **Conflict.** If there is a conflict among documents, the most recently fully executed document will prevail with regard to the conflict.
5. **Understanding, Fair Construction.** By execution of this Amendment, the parties acknowledge that they have read and understood each provision, term and obligation contained in this Amendment. This Amendment, although drawn by one party, shall be construed fairly and reasonably and not more strictly against the drafting party than the non-drafting party.
6. **Severability.** If any provision of this Agreement is determined to be invalid, illegal, or unenforceable, the remaining provisions remain in full force, if the essential terms and conditions of this Agreement for each party remain valid, binding, and enforceable.

IN WITNESS WHEREOF, this Amendment is signed, accepted, and agreed to by all parties by and through the parties or their agents or authorized representatives. All parties hereby acknowledge that they have read and understood this Amendment and the attachments and exhibits hereto. All parties further acknowledge that they have executed this legal document voluntarily and of their own free will.
