


##### **A. Economic Development**

City Manager, Jeff Mihelich, provided a brief overview of the modules for economic development that other Cities use, roles, responsibilities, and identify potential outcomes based on measurements of success.

1. Staff recommends that the Mayor and Council discuss the city's current economic development model and direct staff accordingly following the discussion.  
An overview of the different types of frameworks/models used by municipalities/jurisdictions to tackle economic development.

Staff recommends that the Mayor and Council discuss the city's current economic development model and direct staff accordingly following the discussion.

#### **Worksession Summary:**

The Mayor and Council provided their thoughts and comments including further discussion with Rockville Economic Development, Inc. (REDI) on focusing on accountability, coordination, transparency and residential input; consider establishing a monthly coordination meeting between City and REDI to discuss economic development details and land use outreach; develop strategies to improve public education and communication regarding economic development to address misconceptions and increase accessibility for residents; Look into creating a welcoming process for new businesses during permitting, potentially including sharing resources like leasing toolkits; Direct the city manager and city attorney to create a comprehensive Rockville economic development plan inclusive of the work of REDI and city departments, to be presented for adoption by the mayor and council within approximately one year.

#### **B. 2026 State Legislative Priorities (including Legislative Bond Initiatives)**

Associate City Manager, Linda Moran, provided a brief overview of the 2026 State Legislative priorities.

Staff recommends that the Mayor and Council (i) receive the presentation, (ii) discuss the proposed 2026 State legislative priorities, and (iii) direct staff to bring forth a resolution that includes the approved 2026 State legislative priorities.

**Worksession Summary:**

Should the Mayor and Council choose to provide broad direction on 2026 Rockville State Legislative Priorities, staff will return on October 6, 2025, with a resolution that includes the selected priorities for adoption. Rockville's approved 2026 State legislative priorities will be highlighted at the Legislative Priorities hearing before the Montgomery County Delegation on November 19, 2025. Rockville and its State lobbyist will collaborate with District 17 and other stakeholders to advocate for the adopted priorities in the 2026 General Assembly Session.

Questions from the Mayor and Council were addressed by staff.

The Mayor and Council provided their thoughts and comments including autonomous stop sign monitoring, advocating for support to insure that a Health Care safety net remain viable in Maryland including access to vaccines, Medicaid, Good Cause Bill, public health, tenant protections prohibiting landlords from using certain algorithmic approaches, transparency on rental fees, noise pilot programs with Montgomery County, investigate potential improvements for childcare facilities at Montrose for future legislative bond initiatives, housing protection for teachers and opportunities.
