WITNESSETH:

WHEREAS, 2250 Tower Oaks Boulevard LLC, a Maryland limited liability company (herein referred to as "Owner"), is the owner of the property hereinafter referred to as the "Subject Property," described as follows:

Parcel D, Block D in the Tower Oaks Subdivision recorded as Plat No. 23507 in the Land Records of Montgomery County, Maryland.

WHEREAS, the Owner's predecessors in interest to the Subject Property established a 20 foot by 17 foot Stormwater Management Easement on the Subject Property, as shown on Plat No. 23507 (the "Stormwater Management Easement"); and

WHEREAS, the Stormwater Management Easement was created for the benefit of the City to provide the City with access to a portion of the Subject Property for the purpose of installation, construction, reconstruction, maintenance, repair, operation and inspection of a stormwater management facility and appurtenances thereto within the easement area shown on the plat ("Easement Area"); and

WHEREAS, the portion of the Subject Property on which the stormwater management facility was to be constructed is being redeveloped; as part of this redevelopment, new stormwater management facilities will be constructed to replace the previously proposed stormwater management facility. New stormwater management easements will be recorded concurrently with the termination of the existing Stormwater Management Easement; and

WHEREAS, the City has determined that the existing Stormwater Management Easement is no longer necessary; and

WHEREAS, the existing Stormwater Management Easement to be released is as shown on Plat No. 23507 and is made a part of this Release and Extinguishment (the "Release Area").

NOW, THEREFORE, in consideration of the above recitals, incorporated herein by reference, the City hereby releases to the Owner its rights to the Release Area created by the Stormwater Management Easement, extinguishes all rights and interests in the Release Area, and further declares the Stormwater Management Easement null and void and of no further force or effect with respect to the Release Area.
