City Manager Jeff Mihelich provided a brief overview of the rent stabilization framework presented on July 8, 2024.

Staff recommends the Mayor and Council discuss rent stabilization in this worksession and direct staff accordingly following the discussion.

Worksession topics requested for discussion include:

At the June 16^{th,} 2025, Mayor and Council meeting, Councilmember Myles and Councilmember Shaw requested a worksession for the body to consider a rent stabilization framework that includes:

- 1. Capping rent increases
- 2. Banning junk fees
- 3. Providing exemptions
- 4. Providing a petition process for requested waivers and
- 5. Strong enforcement

The Mayor and Council provided their thoughts, comments, and questions.

Staff will follow up with directions received from the Mayor and Council.

Councilmember Izola Shaw moved to pass a Rent Stabilization Program identical to Montgomery County to cap rent increases to 6%, or the Consumer Price Index (CPI) and 3%, whichever is lower.

B. Worksession #2-Election Consultants Recommendations on City Election Reform-Gant Group

Jason Gant, President of the Gant Group provided the Mayor and Council with an overview of the recommendations on City Election Reform.

Staff recommends the Mayor and Council have a facilitated discussion with the election consultant, Gant Group, and provide input on the following topical areas to enable the consultant to complete the final report. The topical areas include:

- Campaign Finance
- Public financing of local elections
- Campaign Finance Reporting
- Election procedure
- Enforcement mechanism (curing violations and dispute resolution)
- Role of the Board of Supervisors of Elections (BSE)
- Rank Choice Voting
- 2023 Ballot Measures
 - a. Voting age Should Rockville allow 16-17-year-olds to vote in city elections?
 - b. Non-citizens voting Should Rockville allow residents who are not US citizens to vote in city elections?
 - c. Term limits Should Rockville limit Mayor and Councilmembers to 3 consecutive terms?
 - d. Representative Districts Should some or all of the 6 council members be elected by representative districts?

On Monday, May 19, 2025, the Mayor and Council held their first worksession on City Election Reform. The discussion was facilitated by Jason Gant, the election consultant, during which members of the body provided feedback on various aspects of the City of Rockville's elections and election code that should be subject to reform, including campaign financing, campaigning practices, and enforcement of election code violations, among other things. Following this initial discussion with the Mayor and Council, the consultant held two public engagement sessions (June 5th and June 7th) to solicit community feedback on city election reform. In addition to these events, the consultant met with members of the Board of Supervisors of Elections, the City Manager, the City Clerk, and the City Attorney to solicit their thoughts on the City's election process. Some of the feedback received from these engagement activities may be incorporated into the final report and help inform the recommendations

As the consultant works on the final report, guidance is needed on topical areas to assist him in finalizing the report. The topical areas are designed to keep the discussion concise, thereby utilizing the body's time effectively. Within each topical area, the consultant outlines:

- i. The city's current practice and/or pertinent context as background
- ii. A few best practice principles and
- iii. The consultant's approach thus far

Following the discussion, the consultant asks the policy question or questions for the Mayor and Council's consideration on:

- Campaign Finance
- Public Financing of Local Elections
- Campaign Finance Reporting
- Election Procedure
- Enforcement Mechanism
- Role of the Board of Supervisors of Elections (BSE)
- Rank Choice Voting
- 2023 Ballot Measures

After the discussion, the Mayor and Council provided directions on the following:

- Gather feedback from the BSE, staff, and consultants regarding the delineation of duties and clarity on responsibilities, and enforcement mechanisms
- Gather more information on Rank Choice Voting
- Request the consultant to draft a final report with two options: one for maintaining the BSE's administrative functions and another for transitioning them into a policy-recommending body
- Request the Consultant to include in the final report amending our charter to make 16-17-year-olds eligible to vote
- Gather public input on allowing 16 and 17-year-olds to vote in city elections

Following the worksession, the consultant will incorporate the guidance, research, and analysis as he drafts the final report with recommendations. The final report, inclusive of the final recommendations, will be presented to the Mayor and Council on September 8, 2025.
