WHEREAS, 2250 Tower Oaks Boulevard LLC, a Maryland limited liability company (herein referred to as "Owner"), is the owner of the property hereinafter referred to as the "Subject Property," described as follows:

Parcel D, Block D in the Tower Oaks Subdivision recorded as Plat No. 23507 in the Land Records of Montgomery County, Maryland.

WHEREAS, the Owner's predecessors in interest to the Subject Property granted a Water Meter Easement to the Mayor and Council of Rockville, as shown on Plat No. 23507 (the "Water Meter Easement"); and

WHEREAS, the Water Meter Easement was created for the benefit of the City to provide the City with access to a portion of the Subject Property for the purpose of installation, construction, reconstruction, maintenance, repair, operation and inspection of a Water Meter and appurtenances thereto within the easement area shown on the plat ("Easement Area"); and

WHEREAS, the portion of the Subject Property on which the water meter was constructed is being redeveloped; and

WHEREAS, the City has determined that the existing Water Meter Easement is no longer necessary upon the recordation of the new water meter easement described above; and

WHEREAS, the existing Water Meter Easement to be released is as shown on Plat No. 23507 and is made a part of this Release and Extinguishment (the "Release Area").

NOW, THEREFORE, in consideration of the above recitals, incorporated herein by reference, the City hereby releases to the Owner its rights to the Release Area created by the Water Meter Easement, extinguishes all rights and interests in the Release Area, and further declares the Water Meter Easement null and void and of no further force or effect with respect to the Release Area.

Nothing herein shall be deemed to release or otherwise affect any other Easement or Right-of-Way that the Owner has recorded or may record in connection with the Subject Property.
