# **Old Business**

• Commission vote on the final draft of the CAC Annual Report. - Karen Askin Motion made to approve the report with Goals written as proposed by Liz Ortuzar, Seconded by Brian Rogers; In Favor: Melissa Beattie, Liz Ortuzar; Not in Favor: Karen Askin, Frances Bevington.

Discussion about Fiscal Year 2026 goals led to two additional goals being added:

• The CAC continues to advocate that the city begin the process of developing a long-term strategic plan for the arts in Rockville. As is noted in the permanent and temporary public art subcommittee reports, a strategic plan would provide much needed guidance to City's public art programs, in addition to providing a roadmap for the city to achieve other desired outcomes in the arts, such as the designation of the city as an arts and entertainment district.

As was noted in the temporary public art subcommittee report, the CAC recommends
developing a plan for diverse perspectives that represents a shared understanding
among mayor and council, city staff, and the CAC about expectations for community
engagement in the art in public places and art in public development programs.

Discussion about the Publicly Accessible Art in Private Development program: Commissioner Askin made remarks about staff lacking qualifications to manage the program and staff not managing the program. Commissioner Hoffmann made remarks about the Commission not knowing about funds associated with the program and funds had not been managed by staff. Anne O'Dell commented that per the Ordinance, the Commission is not involved in the financial or administrative management of the program, she is regularly involved in managing the program, and that her mentorship and work experience in Public Art in private development qualifies her to manage the program.

Motion to approve report with the addition of the two goals as written made by Susan Hoffmann; Seconded by Liz Ortuzar; All in Favor: Karen Askin, Melissa Beattie, Susan Hoffmann, Liz Ortuzar, Brian Rogers.

Mayor Report: Mayor Monique Ashton, The Mayor and Council Liaison No report, Mayor not present.

Staff Report: Anne O'Dell, Arts and Culture Program Manager and Staff Liaison Susan Hoffmann gave remarks about the mosaic, *Wave: A Celebration of Maryland's Biome*, by artist Paul Santoleri, and expressed thanks to staff who worked on the project. Also gave remarks about how proud people are of the artwork and that Rockville includes public art in public development projects. Anne O'Dell will pass comments to both the Mayor and Council and staff who led the project.
