

## THIRD AMENDMENT

## to Contract 19-064

# BETWEEN THE METROPOLITAN WASHINGTON COUNCIL OF GOVERNMENTS And THE MAYOR AND COUNCIL OF ROCKVILLE ROCKVILLE BUS STOP & SIDEWALK IMPROVEMENTS

THIS THIRD AMENDMENT is made this day, \_\_\_\_\_\_\_, between the Metropolitan Washington Council of Governments, located at 777 North Capitol Street, NE, Washington, DC 20002 ("COG") and the Mayor and Council of Rockville, located at 111 Maryland Avenue, Rockville, MD 20850 ("SUBRECIPIENT"). COG and SUBRECIPIENT are the "Parties" to this Third Amendment.

## WITNESSETH:

WHEREAS, pursuant to Article I, Section 1 of the Charter of the City of Rockville, the "Mayor and Council of Rockville" is the corporate name of the Maryland municipal corporation and body politic commonly known as the City of Rockville.

WHEREAS, COG entered in an agreement with the SUBRECIPIENT, previously identified as the City of Rockville, dated June 27, 2019, for "Enhanced Mobility of Seniors and Individuals with Disabilities Program" (the "Original Contract"); and

WHEREAS, COG and SUBRECIPIENT amended the Original Contract for the FIRST time on March 12, 2021 to extend the period of performance to July 31, 2023; and

WHEREAS, COG and SUBRECIPIENT amended the Original Contract for the SECOND time on October 13, 2023 to extend the period of performance to July 31, 2025 and to revise the SUBRECIPIENT's name from "City of Rockville" to "Mayor and Council of Rockville"; and

**WHEREAS**, the Parties seek to amend the Original Contract for the THIRD time to further extend the period of performance to July 31, 2027 at no cost to either Party.

**NOW**, **THEREFORE**, in consideration of the mutual promises, covenants and representations contained herein and in the Original Contract, as amended, the Parties agree as follows:

# **MODIFICATION 1. SECTION 3. PERIOD OF PERFORMANCE**

The period of performance shall terminate on July 31, 2027.
