### Minutes for RBAC Meeting: Wednesday, November 5, 2025

# **Council Update** (Councilmember David Myles)

- 1) Maryland Department of Transportation meeting to review regulations and request flexibility on state highway signs and speed regulations
- 2) King Farm Farmstead update debate on parking but bike facilities requests have been acknowledged; Most costly model was suggested but allows for more flexible venue options
- 3) No turn on red signs in Town Square high-traffic areas and LPI (leading pedestrian intervals) where walk sign goes on before the car light turns green installed

### <u>50+ Cycling Survey</u> (Carol Kachadoorian)

- 1) Founder of dblTilde Core, non-profit concentrating on older adults wellness and mobility
- 2) Survey in three-Parts (1) cycling history and preferences, (2) visual reference for biking facilities and usage, (3) online journal for photos and trips

- 4) Survey aims to inform planning and improve bicycle facilities for older adults in various communities; Launched for older adults only in US five years ago and in year four in Canada
- 5) Looking to focus on communities and metropolitan areas; can include visuals from Rockville and customize for age 50+ cyclists
- 6) No target audience size but reaching those who bike in Rockville not necessary city residents

#### **City Update** (Bryan Barnett-Woods)

- 1) City has new website; Report a concern under Contact now
- 2) Bike Fix-it Racks are still on their way; bit longer than expected
- 3) Fleet and Monroe shared use path and cyclepath looking for civil engineer
- 4) Rollins Ave Complete Streets project starting next month
- 5) Transit Within Reach Grant questions about designed shared lane markings and shared bikeway path on Lewis Ave near Metro

6) Will look into the Veirs Mill Rd west of Twinbrook Pkwy to connect with the Twinbrook Connector Trail

# <u>Trader Joe's Entrance</u> (Max Silverstone)

- 1) Parking lot entrance with pedestrian signal and bike lanes (near Wood Lane)
- 2) No left turn from parking lot between 5 pm to 6:30 pm (extending hours requested from Morguard, the property owner)
- 3) Suggested concave mirror or warning signal but would be a Morguard decision since this is not public right-of-way
- 4) Perhaps a Watch for Cyclists sign City may not have say but RBAC bringing this up is good.
- 5) Several possible solutions were proposed to address concerns about cyclist and pedestrian safety at this location.

#### **2025 Bike Rides** (Sophie Chan-Wood)

- 1) Haunted History Ride on Sunday with Linda leading and Jake swept; made 5 stops with ghost stories; riders were mostly our Tuesday night regulars
- 2) Brenda at Trek Store suggested a holiday lights ride on Sunday, 12/28. Jake, Wendy and Lynda can help with route, leading and sweeping.
- 3) Riders survey to send out in December for the Meetup members
- 4) Jonathan and Sophie will be leading a group from Twinbrook Metro at 8:30 am to the Ride For Your Life in Bethesda and into downtown DC on Sunday, 11/16.
- 5) Jonathan, Max and Tracy attended WABA's ride on Old Georgetown Road bike lanes. About 16 riders biked from Executive Blvd to Cedar Lane. Planning to repeat this at 8:30 am the first Tuesday of each month, weather permitting.
