A. Public Hearing on Project Plan Application PJT2025-23, an Amendment to the Rockville Center Inc. Planned Development to permit the construction of a 147-unit multifamily building for affordable housing, along with a Building Height Waiver and Parking Reduction at 41 Maryland Avenue.

Senior Planner Christopher Davis provided the Mayor and Council with an overview of the Public Hearing on Project Plan Application PJT2025-23, an Amendment to the Rockville Center Inc. Planned Development to permit the construction of a 147-unit multifamily building for affordable housing, along with a Building Height Waiver and Parking Reduction at 41 Maryland Avenue.

Staff recommends that the Mayor and Council hold the public hearing.

Summary

SCG Development Holdings, LLC, along with Comstock 41 Maryland LLC and Comstock 44 Maryland, LLC (collectively known as the "Applicant), has filed a Project Plan application to permit redevelopment of the existing surface parking lot located at 41 Maryland Avenue into a 12-story multi-family residential building containing a maximum of 147 dwelling units for affordable housing. To allow this project as proposed, an amendment to the Rockville Center Inc., Planned Development ("PD") is required pursuant to Section 25.14.07 of the Zoning Ordinance. The Applicant has also submitted requests to reduce the on-site parking provided to zero (0) spaces and exceed the maximum building height limitations of the MXTD zone by 17.25 feet.

The project is located within Planning Area 1 (Town Center) of the City of Rockville's Comprehensive Plan; Rockville 2040 and the Land Use designation applied to the site is OCRM – Office Commercial Residential Mix.

Public Notification and Engagement

Notifications of the Project Plan application and this Mayor and Council public hearing were made consistent with City Code requirements. In addition, the Applicant held a virtual pre-application area meeting on January 21, 2025, which 29 members of the public attended. The Applicant held a virtual post-application area meeting on April 29, 2025, which 15 members of the public attended.

Boards and Commissions Review

In accordance with Section 25.07.07.6 of the Ordinance, the Planning Commission was briefed on this Project Plan application on May 14, 2025, and the Mayor and Council were briefed on May 19, 2025. At the briefings, the Planning Commission and Mayor, and Council asked questions and offered suggestions concerning the development proposal.

The Comprehensive Plan calls for the development of additional affordable housing throughout Rockville. This project is proposing the development of 147 new affordable housing units. There are several other compatibilities within the proposed project and the Housing chapter of the Comprehensive Plan.

Consider acceptance of the \$1,500,000 Land and Water Conservation Fund grant to fund design, grading, excavation, installation of utilities, as well as to construct pathways, a playground, meadow restoration, community gardens, and purchase picnic tables, signage, and trash cans at RedGate Park and Arboretum, consistent with the RedGate Park Master Plan.

Deputy Director of Recreation and Parks, Chris Henry, provided Mayor and Council with an overview of the \$1,500,000 Land and Water Conservation Fund grant to fund design, grading, excavation, installation of utilities, as well as to construct pathways, a playground, meadow restoration, community gardens, and purchase picnic tables, signage, and trash cans at RedGate Park and Arboretum, consistent with the RedGate Park Master Plan.

Staff recommends the Mayor and Council of Rockville accept a grant of \$1,500,000 administered by the State of Maryland Department of Natural Resources (DNR), funded by the National Parks Service (NPS) Land and Water Conservation Fund (LWCF). This grant has a dollar-for-dollar match requirement, and the matching funds are already included within the RedGate Park Master Plan Implementation (RE23) CIP project.

Questions from the Mayor and Council were addressed by staff. The Mayor and Council provided their thoughts and comments.

Summary

The city has been awarded a LWCF grant of \$1,500,000 for selected design and construction of infrastructure and amenities within RedGate Park and Arboretum. On April 7, 2025, the Mayor and Council approved and authorized the city manager to sign the grant agreement (Attachment 2). The LWCF Notice of Award was sent to the city on August 20, 2025.

The funds for this grant originate from the NPS LWCF State Assistance Program. Among other requirements, acceptance of the LWCF fund requires compliance with the Land and Water Conservation Act of 1965. Section 6(f)(3) of the LWCF Act of 1965 notes that "sites receiving assistance are to be opened, operated, and maintained in perpetuity for 'public outdoor recreation use', or be replaced by lands of equal market value and recreation usefulness."

The grant agreement was approved by Mayor and Council on April 7, 2025. This is the second time this item has been presented to Mayor and Council.

If awarded, the grant requires a dollar-for-dollar match. The RedGate Park Master Plan Implementation (RE23) CIP project has appropriated funds to meet this match requirement. The receipt of additional grant funds to support this capital project will reduce the unfunded portion of the project.

Next Steps

If accepted by Mayor and Council, staff will work with DNR to implement the grant.

12. Worksession

A. Public Safety

Chief of Rockville City Police Jason West and Deputy Chief of Rockville City Police Barry Dufek provided the Mayor and Council with an overview of Public Safety in the City of Rockville.

Staff recommends Mayor and Council receive the Public Safety presentation.

The Rockville City Police Department maintains a staff of both sworn personnel (law enforcement officers) and professional staff who support the mission of the police department by handling many services for the community that do not require a sworn officer. The non-sworn positions include police communication operators (dispatchers), parking enforcement officers, neighborhood services officers (animal control), and the administrative support staff. The department was granted two new professional staff positions in the FY26 budget, which have allowed the police department to better serve the community with improved efficiency and quality.

The department added two important positions for our sworn personnel. These positions were developed through internal promotions of existing staff. The department now has a designated Training Sergeant. The Training Sergeant oversees the management and organization of all mandatory training sworn officers must complete from year to year for the purpose of Maryland certification.

The department expanded the police department's Community Engagement Officer (CEO) program by assigning an officer to Wootton High School for the 2025-2026 school year. This new position extends the police department's outreach in the public school system for the mutual benefit of the school staff, parents and public-school students. This new assignment will work in the same capacity as the CEO assigned to Richard Montgomery High School.

The department has filled all vacant police positions since November of 2024, which constitutes a total of 18 new police officers. Those police officers are comprised of lateral or experienced police officers from other jurisdictions and police recruits who are currently attending basic police academy sessions. The department has 11 recruit officers in two academies, the Montgomery County Police Academy and the Frederick Police Academy. Those classes will graduate in December and January. This will put 11 more police officers on duty in the City of Rockville.
