- Upcoming performances and events for Rockville Concert Band, Rockville Chorus, Rockville Civic Ballet, and Glenview Mansion Art Gallery were given.
- Upcoming filtering sessions for King Farm Farmstead planning were provided.
- Strategy for assembling the CAC Annual Report by working through Committee Chairs was shared.
- No communications from Commissioners to the Mayor and Council were given.
- Question of confirming who is responsible for the landscaping Memory Walk Park was asked.

Art in Public Places - Temporary Works Committee: Francis Bevington

- College Gardens Park mural is scheduled to be installed the weeks of June 2 and June 9. Dedication is being planned for July 2025.
- Twinbrook Community Recreation Center Annex mural's final design is to be received. Mural will be painted on Polytab and installed on the wall of the building.
- Friends of the Arts funded events:
 - Operation ARTS was contracted for PRIDE 2025. Volunteer activities include setting up for the event starting at 1pm. Anne O'Dell will connect commissioners who would like to attend with the Human Rights Commission planning committee for more details.
 - F. Scott Fitzgerald Literary Festival community engagement/community arts activity is still in early stages of planning.
- Deaccessioning of *The Hatter of Rockville* is complete.

Art in Public Places - Permanent Works Committee: Liz Ortuzar

- The Swim and Fitness Center mosaic by Paul Santoleri is being installed on schedule.
- Lincoln Park Memory Walk Park public art project is moving forward. The Art Selection Committee has met, done a walk through of the park, and the call for proposals is in its final drafting stages. The call should be released in late May or early June.
- Conservation and Maintenance are scheduled to begin the week of August 25.

New Business - Commissioners discussed what would be included in the CAC Annual Report. Initial ideas are:
