Staff Report: Anne O'Dell, Arts and Culture Program Manager and Staff Liaison

- Updates given about previous month's city-managed arts programs and current public art projects.
 - Deaccessioning The Hatter of Rockville and College Gardens Park mural final design are on the Mayor and Council's April 28 consent agenda.
 - o The Twinbrook CRC Annex mural final design has not been received.
- A high-level review of the Arts and Culture Program Manager's FY26 Workplan and five-year plan was given. The number one priority is to build relationships and design sustainable programs in the arts and culture sector.
- Cultural mapping will be done in FY26. It is the process of identifying artistic and cultural assets in a community.

- High-level review of the MSAC's Arts and Entertainment District program. Discussion included:
 - What the program is and the application process, which is extensive.
 - o According to the criteria, Rockville would not be a competitive applicant.
 - It may be beneficial to focus on initiatives that build a thriving arts scene in Rockville before pursuing an arts and entertainment district designation.
 - Next steps were shared with the CAC if the CAC decides they recommend the city pursue AED Designation.
